All of this can make your head spin, but I am here to help.

Don't Forget!

As of October 1, 2007, Quality Carriers will be changing the compliance policy from 30% to 20%. This means that if you have 20% of log violations within a month, you may be put out of service for 7 days.

Reminder

As of October 1, 2007, shipping papers must include a packaging description. This is part of the requirements of HM215E.

Drivers:

Please ensure that shippers include packaging description on shipping papers. If the shipper is not adhering to these requirements, please call your dispatcher.

The following information will satisfy the requirement::

I Cargo Tank

You can place the information before or after the basic description, along with the amount of product. You do not need to indicate specification of the trailer or any compartment information.

Section 172.202 (a) (7)

(7) The number and type of packages must be indicated by the description of the package..

(c) The type of packaging... may be entered in any appropriate manner before or after the basic description.
